We printed this summary afterwards and may not be in the same sequence as the online application. At least you have an understanding of the questions asked.

Please note!

- \rightarrow All questions must be answered in English
- → We submitted our form in January, but were not able to go to the Embassy until October for the interview and receipt of the visa.
- → In the application there is a question about arrival date, departure date and address where you will be staying. We couldn't plan that 10 months ahead. We entered a date and looked up a hotel and entered those details in the application.


